I think the problem at present is that the law relating to the various diligences is all over the place. Some of it is in the common law, some in several different statute, some in rules of court, and it would make practitioners' and legal advisers' lives, not to mention debtors' lives, much easier if all the law were in the one place, accessible and intelligible.

Scotland's legal system will not grind to a halt if diligence is not rationalised and consolidated. But it might nevertheless make debt recovery easier and more efficient thus cutting the cost for debtor and creditor alike.
